

7.0 KLYP Fee Schedule

To make KLYP the best Cosmetology platform we spent over three-years listening and shadowing providers and consumers to learn what you want and need and what was fair.

Today most convenience applications charge 40% or more on small transactions and 25%, 30%, and in Cosmetology up to 60%, KLYP is more friendly. Providers participate in two ways, transactional fees and a subscription fee, covering different areas that help KLYPISTS to earn more and keep more of their hard-earned income.

Consumers have a single Platform Fee included in the service fee, that is tiered to optimize affordability. This platform fee covers the costs to service transactions and provide customer service. Payment processing fees for payment cards and other payment options are covered by the transaction fees.

Provider Transaction Fees also help cover the costs of servicing transactions; however, the majority of the provider transaction fee supports outbound marketing of KLYPISTS on KLYP so providers can earn even more. This brings the power of Branding to the individual provider.

NOTE: The Client transaction fee is added to the base provider fee and the provider fee is based on the amount before the Client Platform fee, this saves KLYPISTS money.

Provider Subscription Fees

Provider subscription fees cover fixed costs that allow KLYP to provide the platform, service KLYPISTS, and related support services.

Basic: \$29.99/mo or \$285/year.

Search access, provider profile and services with client reviews and ratings. Access to KLYP marketing events and KLYP SEO leverage.

Prime: \$69.99/mo or \$670/year.

Prime subscription fees add Preferred Search Access and Event Access, Accidental injury insurance, Prime professional liability insurance coverage, Access to Mobile Service offerings, Plus Taxbot automated expense tracking.
